TERMS & CONDITIONS



I. Terms and Conditions of Auction

The property will be offered for sale as three (3) parcels. This online auction will be held from Friday, April 4, 2025 at 10:00 am, CST until Tuesday, April 8, 2025 at 11:00 am, CST. All bids will be taken without regard to a prospective bidder's sex, race, color, religion or national origin.

A. If you are the successful bidder on this property, you will be required to provide a 10 PERCENT of the purchase price earnest money deposit and are required to complete and sign a North Dakota Real Estate Purchase Agreement provided by the Auctioneer.

B. If you are the successful bidder on this property, your 10% earnest money deposit will be held in escrow until the closing date. All documentation will be available for your review prior to commencement of the auction. All real estate sales must be closed and the total balance of the purchase price paid on or before May 28, 2025 (Early possession is available). During the days following the auction, you will be contacted by the closing agent to schedule your closing date and time.
