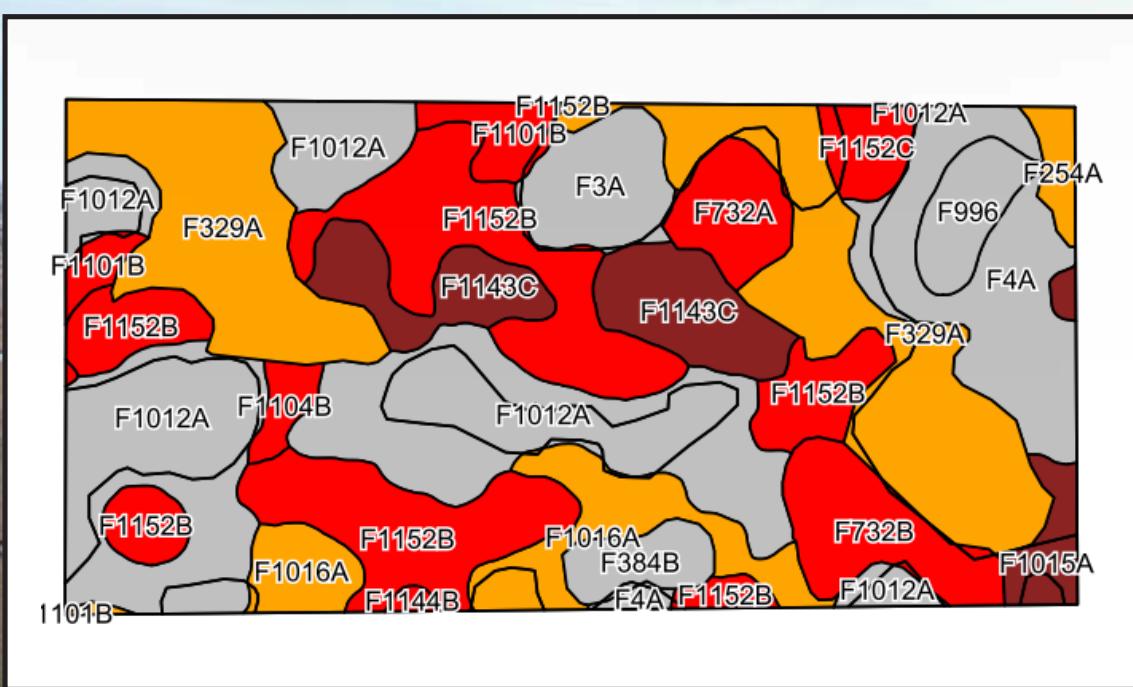
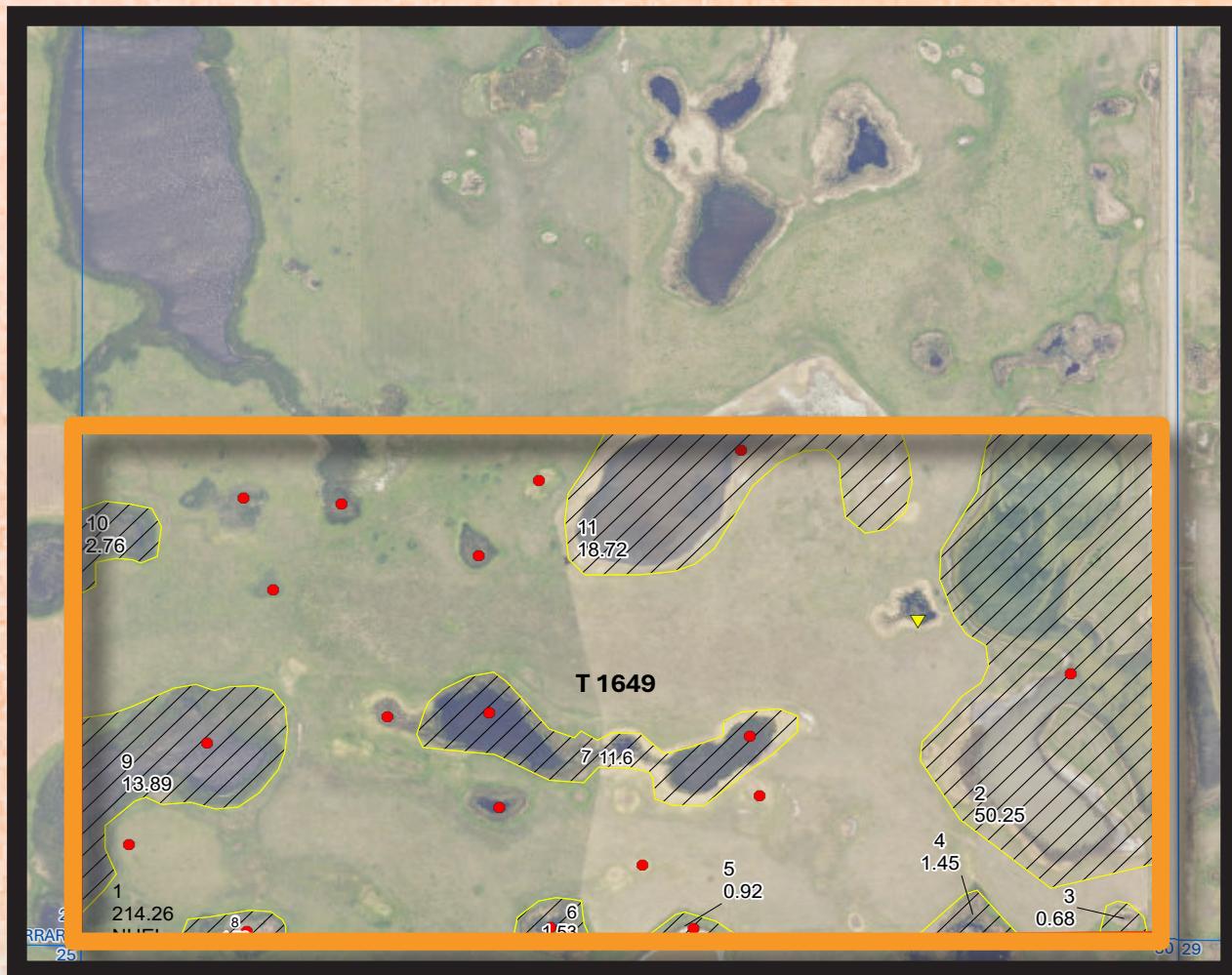
PROPERTY LOCATION

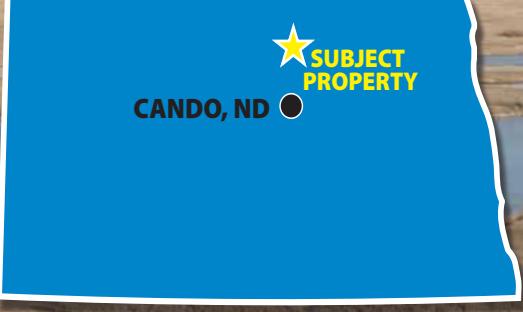
