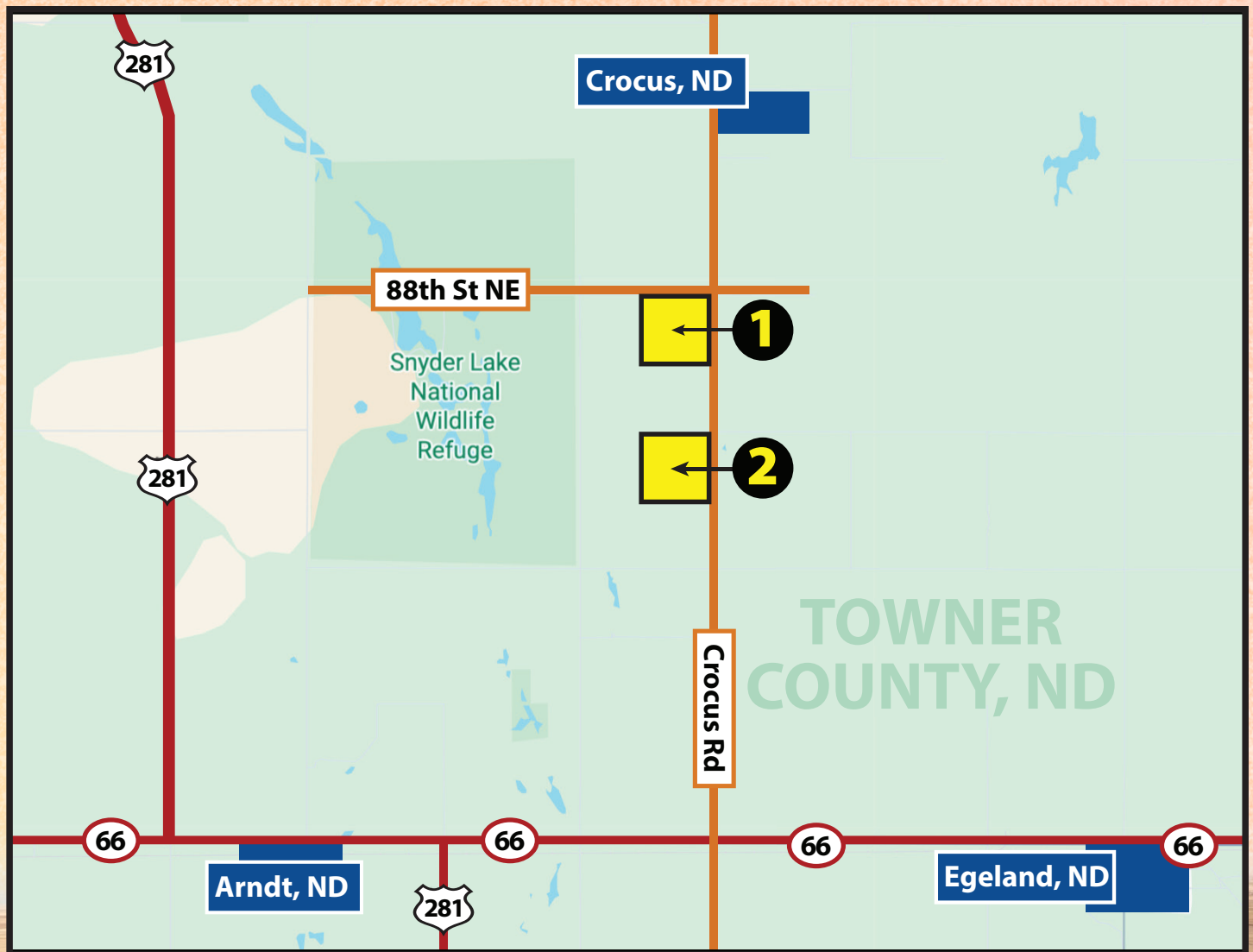

**3 MILES NORTHWEST OF EGELAND, ND!**



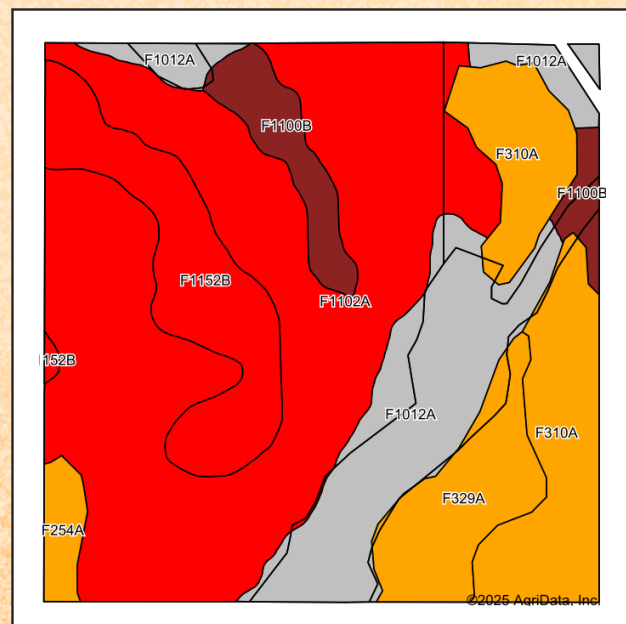

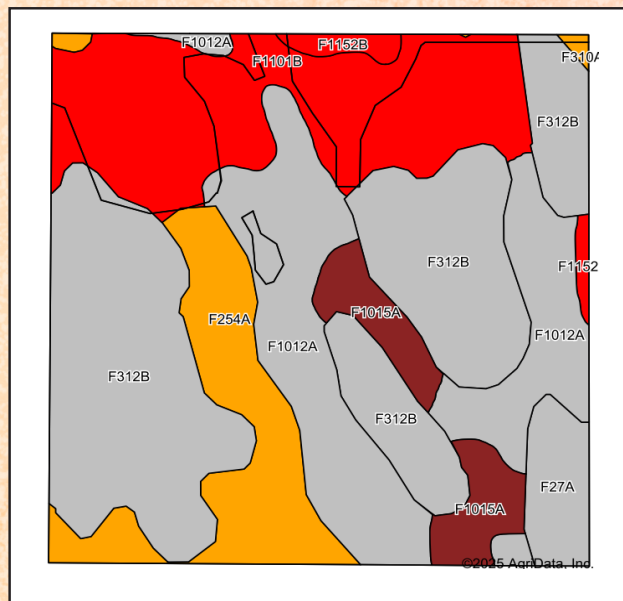

## I. Terms and Conditions of Auction

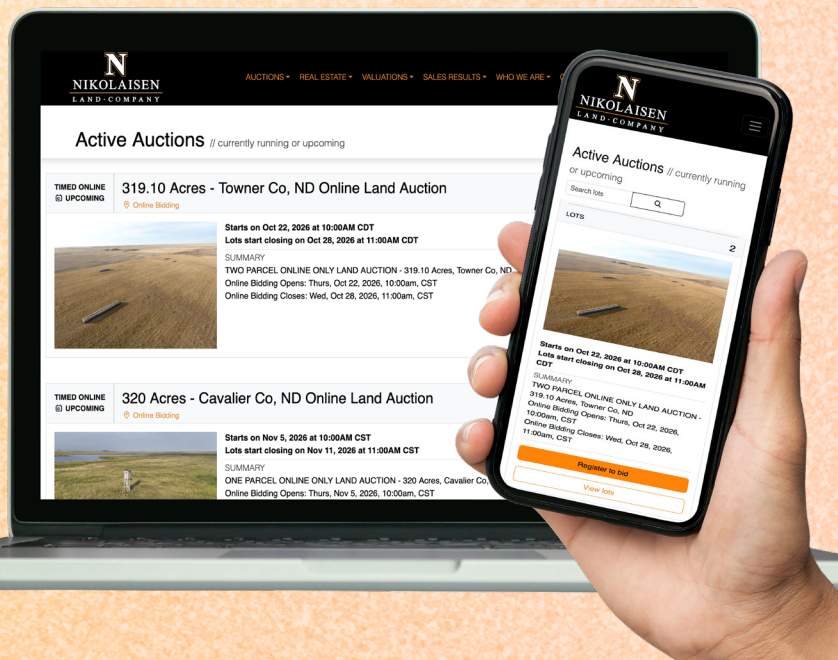
